And by participating, they expressly assume any and all risks of injury, death or loss. They agree to indemnify and hold harmless, the competition (including but not limited to, their officials, sponsors, directors, employees and agents), from and against all claims including any injury, death or loss suffered during or in connections with competition, whether or not such claim, injury, death or loss resulted, directly or indirectly from the negligent acts of omissions of said officials, sponsors, directors, employees or agents of the competition. The inherent risks of equine activity include but are not limited to, any of the following: the propensity of an equine to behave in ways that may result in injury, death or loss to persons on or around the equine; the unpredictability of an equine's reaction to sounds, sudden movements, unfamiliar objects, persons or other animals; hazards, including but not limited to, surface or subsurface conditions; a collision with another equine, another animal, a person or object; and the potential of an equine activity participant to act in a negligent manner that may contribute to an injury, death or loss to the participant or another person, including but not limited to failing to maintain control over an equine or failing to act with the ability of the participant.
