



# 2024 Warren County Fair County Born Market Goat Registration Form

Due May 1, 2024, by 4:30 p.m. to the Warren County Extension office.  
*This form must be completed in full, including signatures, by the deadline.*

1. No late forms will be accepted. Forms will not be accepted at tagging.
2. Forms must be filled out completely, including signatures, by the deadline.
3. Animals without completed forms on file by the deadline will not be tagged as county born market goats.
4. **All goat projects, including wethers, must have a scrapie tag/tattoo. The scrapie tag/tattoo is required when identifying your projects using the 4-H online system.**
5. **Market goats will no longer be tagged in May. Exhibitors are required to register their market goats using the 4-H online system. A front view and side view picture are required. Scrapie identification is required when registering your projects. A maximum of three market goats per exhibitor may be registered.**
6. Since the ownership deadline is May 1, 2024, and only three market goats may be tagged:
  - No substitutions can be made after this form's deadline.
  - Only three market goats may be registered per exhibitor.
  - Only one exhibitor can be listed as the owner. Family or farm names are not permitted.
  - The animal's Scrapie tag numbers must match the online registration information.

## **County Born Eligibility Rules**

1. Goats must have been produced by a Warren County goat producer. The doe must be owned by the producer and the project must be kidded in Warren County. Except for breeding season, does must be housed in Warren County year-round. Does kidding or permanently residing in other counties or states, even if they are owned by a Warren County goat producer, are not eligible for the county born class.
2. The acceptable method for identifying county born market goats (both wethers and does) is with the farm's Scrapie identification tag. The Scrapie tag's farm identification number and individual number must be included on the registration form. Scrapie identification tags are required for all market goats.
3. The breeder must sign this form stating all information provided is true.
4. Warren County Fair personnel reserve the right to inspect does and kids to verify location, ownership, and existence
