



2024 Warren County Fair County Born Market Lamb Registration Form

Due May 1, 2024, by 4:30 p.m. to the Warren County Extension office.
This form must be completed in full, including signatures, by the deadline.

1. No late forms will be accepted. Forms will not be accepted at tagging.
2. Forms must be filled out completely, including signatures, by the deadline.
3. Animals without completed forms on file by the deadline will not be tagged as county born market lambs.
4. **All lamb projects, including wethers, must have a scrapie tag/tattoo. The scrapie tag/tattoo is required when identifying your projects using the 4-H online system.**
5. **Market lambs will no longer be tagged in May. Exhibitors are required to register their market lambs using the 4-H online system. A front view, side views and a picture of the scrapie tag are required. Scrapie identification is required when registering your projects. A maximum of three market lambs per exhibitor may be registered.**
6. Since the ownership deadline is May 1, 2024, and only three market lambs may be tagged:
 - No substitutions can be made after this form's deadline.
 - Only three market lambs may be registered per exhibitor.
 - Only one exhibitor can be listed as the owner. Family or farm names are not permitted.
 - The animal's Scrapie tag numbers must match the online registration information.

County Born Eligibility Rules

1. Lambs must have been produced by a Warren County sheep producer. The ewe must be owned by the producer and the project must be lambbed in Warren County. Except for breeding season, ewes must be housed in Warren County year-round. Ewes lambing or permanently residing in other counties or states, even if they are owned by a Warren County sheep producer, are not eligible for the county born class.
2. **Market lambs must have a scrapie tag that matches this registration form.**
3. The breeder must sign this form stating all information provided is true.
4. Warren County Fair personnel reserve the right to inspect ewes and lambs to verify location, ownership, and existence.
